## CONTRACT SPECIFICATIONS

### 6. Description of the contract

The contract includes supply, delivery, installation and acceptance of a complete wind energy system and solar thermal system. The wind turbine will be in the range of 300 KW, and the solar thermal system also in the range of equivalent to 300KW.

### 7. Numbers and titles of lots

Two lots:

Lot No.1 : Wind turbine system

Lot No.2 : Solar thermal system

## TERMS OF PARTICIPATION

### 8. Eligibility and rules of origins

Participation is open to all legal persons [participating either individually or in a grouping (consortium) of bidders ] which are established in a Member State of the European Union or in a country or territory of the regions covered and/or authorised by the specific instruments applicable to the programme under which the contract is financed (see item 3 above). All goods supplied under this contract must originate in one or more of these countries. Participation is also open to international organisations. Participation of natural persons is directly governed by the specific instruments applicable to the programme under which the contract is financed.

### 9. Ground for exclusion

Bidders must submit a signed declaration, included in the Bid Form for a Supply Contract, to the effect that they are not in any of the situations listed in point 2.3.3 of the Practical Guide to contracts procedures for EC external actions.

### 10. Numbers of bids

Bidders may submit only one bid per lot. Bids for parts of a lot will not be considered. Any bidder may state in its bid that it would offer a discount in the event that its bid is accepted for more than one lot. Bidders may not submit a bid for a variant solution in addition to their bid for the supplies required in the bid dossier.

### 11. Bid guarantee

Bidders must provide a bid guarantee as follow: Lot 1: 20,000 EURO, Lot2:15,000 EURO, when submitting their bid. This guarantee will be released to unsuccessful bidders once the bid procedure has been completed and to the successful bidder(s) upon signature of the contract by all parties. This guarantee will be called upon if the bidder does not fulfil all obligations stated in its bid.

### 12. Performance guarantee

The successful bidder will be asked to provide a performance guarantee of 10% of the amount of the contract at the signing of the contract. This guarantee must be provided together with the return of the countersigned contract no later than 30 days after the bidder receives the contract signed by the Contracting Authority. If the selected bidder fails to provide *such* a guarantee within this period, the contract will be void and a new contract may be drawn up and sent to the bidder which has submitted the next cheapest compliant bid.

### 13. Information meeting and/or site visit

Site visit is planned at the 30th June 2011 at 10.00 a.m. at Al-Ahli Hospital, Hebron, West Bank, Palestinian Territories

### 14. Period of implementation of tasks

12 months from contract signature until the provisional acceptance.

## SELECTION AND AWARD CRITERIA

## 15. Selection criteria

The following selection criteria will be applied to bidders. In the case of bids submitted by a consortium, these selection criteria will be applied to the consortium as a whole:

1) Economic and financial capacity of bidder (based on i.a. item 3 of the Bid Form for a Supply Contract). In case of bidder being a public body, equivalent information should be provided.

2) Professional capacity of bidder (based on i.a. items 4 and 5 of the Bid Form for a Supply Contract)

3) Technical capacity of bidder (based on i.a. items 5 and 6 of the Bid Form for a Supply Contract)
